ARTICLES OF INCORPORATION

Q-419 GREENSBORO CONDOMINIUM OWNERS ASSOCIATION

We, the undersigned, for the purposes of forming a corporation pursuant to the provisions of the Minnesota Non-Profit Corporation Act (Minnesota Statutes Chapter 317) hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of this Corporation shall be Greensboro Condominium Owners Association.

ARTICLE II

PURPOSES

The purposes for which the Corporation is formed are as follows:

- a. To act as the Association which is referred to in the Declaration Establishing a Plan for Apartment Ownership Pursuant to the Minnesota Condominium Act (the "Declaration") for Greensboro Condominiums filed for record pursuant to the Minnesota Condominium Act with the Office of the Hennepin County Recorder, Minneapolis, Minnesota, which Association will provide for the operation and management of Greensboro Condominiums as required by the Minnesota Condominium Act; and

b. To act as a "condominium management association" within the meaning of Section 528 of the Internal Revenue Code of 1954.

ARTICLE III

NO PECUNIARY GAIN

This Corporation shall not afford pecuniary gain, incidentally or otherwise, to its Members.

ARTICLE IV

DURATION

The duration of this Corporation shall be perpetual.

ARTICLE V

REGISTERED OFFICE

The location of the registered office of this Corporation shall be 3647 McKinley Street N.E., Minneapolis, MN 55418.

The Members of this Corporation shall not be subject to any personal liability for corporate obligations.

ARTICLE IX

CAPITAL STOCK

This Corporation shall have no capital stock. Cumulative voting by members shall not be permitted.

ARTICLE X

MEMBERS

The members of this Corporation shall be those persons described as Members in the By-Laws of the Corporation.

ARTICLE XI

ADOPTION OF BY-LAWS

The First Board of Directors shall, upon the first meeting thereof, adopt By-Laws for the regulation of the business of the Corporation.

ARTICLE XII

MEETINGS

The Corporation shall hold meetings of its Members, at such time and in such manner as shall be specified in the By-Laws.

ARTICLE XIII

DISSOLUTION

Upon dissolution of the Corporation, after payment of all of the debts and obligations of the Corporation, all remaining corporate assets shall be distributed to each Member of the Corporation in proportion to that Member's ownership of the Common Areas and Facilities as provided in the Declaration mentioned in Article II above.
